This grant, also requiring matching funds of \$16,125, will be used to reduce "Part I" crimes and provide crime prevention information to citizens in the community. The Salisbury Police Department will employ a crime data analyst, purchase one firewall protected intranet server and fourteen mobile printer to enhance the agency's current mobile network. This project will provide crime analysis maps and integrated crime prevention information to the mobile data computer for distribution to officers, victims and citizens.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY ACCEPTING STATE GRANT FUNDS AWARDED THROUGH A BYRNE MEMORIAL GRANT FROM THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION TO FUND A CIVILIAN POSITION OF CRIME DATA ANALYST AND PURCHASE EQUIPMENT TO REDUCE PART I CRIMES AND PROVIDE CRIME PREVENTION INFORMATION TO CITIZENS IN THE COMMUNITY.

WHEREAS, state funds were awarded in a Byrne Memorial Grant by the Governor's Office of Crime Control and Prevention to fund a Mobile Crime Analysis/Prevention program;

WHEREAS, the grant funding will be used to employ a Crime Data Analyst and purchase a firewall protected intranet server and fourteen mobile printers to enhance the Salisbury Police Department's current mobile network;
