A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY AMENDING THE FISCAL YEAR 2005 GENERAL FUND BUDGET TO PROVIDE FOR THE DEPOSIT OF STATE GRANT FUNDS AWARDED THROUGH THE GOVERNOR'S OFFICE OF CRIME CONTROL AND PREVENTION TO ENHANCE COMMUNITY POLICING EFFORTS AND QUALITY OF LIFE ISSUES IN THE DESIGNATED CSAFE II AREA.

WHEREAS, the Salisbury Police Department is family-focused, culturally competent, and responsive to the strengths, needs and priorities of families and children in the City of Salisbury;

WHEREAS, this State grant was awarded by the Governor's Office of Crime Control and Prevention through the Wicomico Partnership for Families and Children for CSAFE II initiatives in the Westside neighborhoods of Salisbury;
