

A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY, MARYLAND ACCEPTING A CASH REGISTER AND INVENTORY SOFTWARE SYSTEM FROM THE SALISBURY ZOO COMMISSION TO PROVIDE IMPROVED INVENTORY TRACKING AND ACCURACY AT THE SALISBURY ZOO'S OCELOT SPOT GIFT SHOP.

WHEREAS, the Salisbury Zoo's Ocelot Spot Gift Shop provides \$75,000 in annual revenue for zoo operations supported financially by the Salisbury Zoo Commission;

WHEREAS, the Salisbury Zoo Commission will provide \$3,500 to purchase a new cash register and inventory software system for the Ocelot Spot Gift Shop;

WHEREAS, the new cash register and software system will improve the inventory tracking and accuracy, and improve efficiency by preventing double entry for inventory items;

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Salisbury, Maryland does hereby accept the donation of a new cash register and inventory software system for the Ocelot Spot Gift Shop at the Salisbury Zoo.
