Attached is a copy of the application requesting Enterprise Zone designation from Victor L. Disharoon of Wicomico Heating and Air Conditioning. I have reviewed this application and, to the best of my knowledge, this establishment meets all of the qualifications to be so designated. This property is located within the boundaries of the City's Enterprise Zone and they have invested more than \$50,000 in the property recently.

I recommend that the City Council adopt the attached resolution designating Wicomico Heating and Air Conditioning, located at 621 Railroad Avenue, eligible to receive the benefits of the Enterprise Zone.

The Mayor concurs with this recommendation.

As a reminder, companies that are declared eligible for enterprise zone benefits are able to receive both income tax and property tax benefits for ten years. The purpose of this program is to encourage industries to locate in areas identified as enterprise zones and to reinvest in such properties.

RESOLUTION NO. 1210

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND DECLARING THAT WICOMICO HEATING AND AIR CONDITIONING, LOCATED AT 621 RAILROAD AVENUE, IS ELIGIBLE TO RECEIVE ENTERPRISE ZONE BENEFITS

WHEREAS the City of Salisbury, Maryland and Wicomico County created an Enterprise Zone on June 6, 1983 for the purpose of encouraging economic development of the area encompassed within the boundaries of such zone; and

WHEREAS the Enterprise Zone was created under authority granted by the State of Maryland; and

WHEREAS the State Code permits certain benefits to be extended to businesses that locate or expand in the Enterprise Zone provided that they meet certain standards; and

WHEREAS, the City of Salisbury and Wicomico County have also established certain standards, which must be met in order for a business to be deemed eligible to receive Enterprise Zone benefits; and

WHEREAS, Wicomico Heating and Air Conditioning, located at 621 Railroad Avenue, meets the standards set forth in the State Code and in local regulations to be eligible to receive Enterprise Zone benefits; and

WHEREAS, Victor L. Disharoon has requested that the company be designated as eligible for Enterprise Zone benefits due to their investment in the property since they located in the zone at 621 Railroad Avenue;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Salisbury, Maryland that Wicomico Heating and Air Conditioning be designated as eligible to receive the benefits of the Enterprise Zone effective upon the adoption of this resolution.
