The Chipman Center Elevator Project, which is grant funded under the Community Legacy Grant, has been advertised for bid on three occasions. The first round produced no bidders, the second round produced one bid that was twice the budget available and one non-responsive bidder. The third round has produced a bidder who is responsive and whose references are acceptable. However, the price for the construction is \$5,000.00 over the grant funds available. As such, I am requesting assistance in the form of a funds transfer from the City's Contingency Fund. Attached is a Resolution to present to Council for approval of the transfer.

The project is over the time allowed by the Department of Housing and Community Development. An extension has been granted and we have until April 30, 2005, to complete the project. However, an additional extension will be requested as the elevator shaft takes eight weeks to be delivered.

## THE COMMUNITY LEGACY - CHIPMAN ELEVATOR PROJECT.
