Governor Ehrlich to Present Community Legacy Award in Salisbury
State Funds Totaling More Than \$66,300 Support Revitalization Initiatives in Wicomico County

SALISBURY, MD – Governor Robert L. Ehrlich and Maryland Department of Housing and Community Development (DHCD) Secretary Victor L. Hoskins will present a Community Legacy award totaling \$66,318 at a April 23, 3:30 PM ceremony at the 200 Block of Main Street in Salisbury. Mayor Barrie P. Tilghman, City of Salisbury, State and local-elected officials are also scheduled to attend.

"Creating affordable housing and revitalizing communities is a critical issue to this Administration, "said Governor Ehrlich. "The Community Legacy funds awarded to Salisbury will positively impact not only the city, but Maryland citizens who desperately need housing opportunities made available."

"We are gratified that the State, through the Community Legacy Program, has been so overwhelmingly supportive of our efforts to revitalize our traditional and oldest neighborhoods," said Mayor Tilghman. "The momentum that we have built over the past four years will truly have a positive and meaningful impact in the City of Salisbury for many years to come."

The State funds will go toward the demolition of approximately 11 substandard/condemned properties. The properties located along Rose and Lake Streets were purchased by Salisbury Neighborhood Housing Services, Inc. (SNHS), a nonprofit organization incorporated to stimulate and coordinate efforts to revitalize city neighborhoods among residents, city government and the local financial community. The demolished properties will be replaced by new homes to be sold at below market-rate to low- to moderate-income families.

"The Ehrlich-Steele Administration is committed to creating clean, safe, decent and affordable housing, and we are proud to aid in this essential mission, "said DHCD Secretary Hoskins. "The Community Legacy funds are used to revitalize neighborhoods and help create a healthy and vibrant living environment for Marylanders."

The Community Legacy Program is administered by the DHCD Division of Neighborhood Revitalization, and provides flexible capital and operating resources through annual competitive funding rounds to assist local governments and their nonprofit partners in planning and realizing comprehensive community revitalization initiatives. The awards are intended to fill critical funding gaps for state-supported initiatives.

A cabinet-level State agency, the Maryland Department of Housing and Community Development is committed to expanding homeownership and affordable housing opportunities, strengthening and revitalizing communities, and preserving Maryland's heritage.

BACKGROUND:

Community Legacy, a program of the Department of Housing and Community Development (DHCD), is designed to assist urban neighborhoods, suburban communities and small towns that are experiencing decline and disinvestment, but have the potential, with modest public and private investment, to be vibrant places to live and work. Indications of decline include dropping property values, population loss, decreasing income and education levels, and increasing housing and commercial vacancies. Indications of community strength include proximity to transportation or commercial town centers, major employers or educational or other institutions; partnerships with local banks, businesses, and community organizations; and community leadership.

Older communities have the potential for a beauty and spirit that is nearly impossible to build new. If our existing communities can attract families and businesses, Maryland's goals can be achieved: Maryland's towns and cities will be vibrant centers of community; thousands of acres of farmland and open space will be protected from sprawl development; and State taxpayers will not be asked to meet the social and economic costs of abandoned communities while simultaneously meeting the costs of new growth.

Community Legacy provides flexible capital and operating resources through annual competitive funding rounds to assist local governments and their nonprofit partners in planning and realizing comprehensive community revitalization initiatives. It is intended to fill key

gaps in State support for such efforts.
