

A RESOLUTION OF THE COUNCIL OF THE CITY OF SALISBURY ACCEPTING GRANT FUNDS AWARDED THROUGH THE WICOMICO PARTNERSHIP FOR FAMILIES AND CHILDREN TO PROVIDE FOR REIMBURSEMENT OF PERSONNEL COSTS AND THE PURCHASE OF EQUIPMENT TO ENHANCE COMMUNITY POLICING AND REVITALIZATION EFFORTS IN THE DESIGNATED WEED AND SEED AREAS.

WHEREAS, these funds were awarded through the Wicomico Partnership for Families and Children for Weed and Seed initiatives in each target location: Camden, East Church Street and Westside neighborhoods;

WHEREAS, the use of these grant funds will allow increased police presence and interaction with residents and businesses to address their concerns and priorities in each neighborhood;

WHEREAS, these funds will be used for the purchase of equipment for the Weed and Seed areas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALISBURY, MARYLAND that the awarded grant funds in the amount of \$40,000 be deposited in the City's Law Enforcement Grant Fund and used for reimbursement of personnel costs to enhance community policing and revitalization efforts in the designated Weed and Seed areas and to fund equipment purchases for use in the Weed and Seed areas.
